Minutes of meeting of the Ex-ONGC Executives Welfare Association, New Delhi

Date: - 12/02/2023

The AGM was convened specifically to hold the elections for the new executive body of the Association for the next two years. Notice to this effect had been shared several times through whatsapp and also through EOEWA website.

The quorum was not present at 11 AM, the scheduled time for AGM, and so it was delayed by half an hour as per the procedure, and started at 11.30 hours.

At the outset of the meeting, Shri S K Jain, Secretary EOEWA, welcomed all the members and thereafter briefed about the activities conducted during the last 1 year and highlighted the picnic organized at the Lohagarh farms and trip organized to North East of India. Both these programmes had been appreciated by the members.

Then, he requested the President Shri A K Hazarika to address the gathering. The President appreciated the work done by the executive committee during his tenure and also thanked the members for their active participation and support in all the activities carried out during their tenure.

Then the Secretary requested Shri Shiv Dayal, treasurer to present the accounts statement to the house. Shri Shiv Dayal, treasurer of EOEWA, presented the accounts of the association for the year and informed about the earnings and expenditure of the association. He further informed that association has, as on date, FD of Rs. 58 lacs.

Thereafter, all the ex-executives who have attained the age of 80 years since last such felicitation, were felicitated by the executive committee.

Since, EPS issue was of interest to all ex-executives, association had requested Mr. Nishant Kumar, DGM HR i/c SEE cell, to be present in the meeting and apprise the members about the ongoing developments on EPS. Mr. Nishant Kumar accordingly informed the house about the ongoing developments on the EPS issue and clarified the status of EPS as on date. Further he informed that ICE team is calculating the approximate amount to be deposited by each member for getting enhanced pension. Though, he informed that still many things are not clear and ONGC as a precautionary measure is taking joint option form from the ex-employees. As and when other clarifications are received from the headquarters, same shall be shared with the ex-executives.

Shri A K Hazarika, President, invited Shri BC Bora, Patron, who had been appointed Returning Officer for holding the elections by the EC in one of its earlier meetings, and announced resignation of all members of the Executive Body.
